





DYNAMIC FOAM

To make our products more durable and uniquely comfortable, we use a material called cold-cure molded foam. This material is the reason our chairs retain their shape and flexibility year after year. The foam contains really small air pockets, tiny bubbles within its denser structure, which allows for just the right amount of firmness. After the foam is shaped, the cover is hand-sewn for it to fit perfectly. The result? Chairs that look elegant from all angles and will not sag.

WARRANTY ON FOAM AND METAL FRAME


KEBE provide a 10-year warranty on foam and the inside steel frame and springs.

	Swivel	Smooth and soundless. The swivel base allows you to turn in any direction you wish.	
FUNCTIONS	Push back recliner	Also known as 'manual recliner'. Allows you to recline the chair by pushing the backrest. It can be folded to various degrees, according to your preference.	
FUNC	Electric function recliner	The smooth mechanism is powered by a battery, making you unfold the backrest with just a push of a button.	
	Headrest Plus	This is a height adjustable headrest. This solution allows you to adjust the headrest vertically (up/down) and horizontally (front/back). It is built into selected chairs.	
	Return swivel	Allows the chair to automatically swivel back into its original position once you stand up.

ELECTRICAL CHARACTERISTICS

WARRANTY OF MECHANISM

The manufacturer provides a warranty for the period of:

- 2 years for mechanical (non-electrical) components,
- 1 year for electrical components. The exception is the Piro module (with 2 motors installed), where the period is 2 years.

EFFECTIVE USE OF THE BATTERY PACK

- Fully charge for 8 hours before first use.
- To maintain battery performance, fully charge it every 3 months.
- To maintain battery performance, we recommend that you fully charge it in an ambient temperature of 10 ° C ~ 30 ° C.

CAUTION FOR USE

- The battery should be kept away from fire and high temperature areas.
- Never expose the battery to temperatures over 60 °C, such as direct sunlight or a car parked in the sun.
- To prevent a short circuit, do not put any metal objects into the battery terminal.
- Do not subject the battery to mechanical shocks.
- Do not disassemble or modify the battery.
- Keep the RC-Battery Pack out of the reach of children.

WARRANTY & BATERY LIFE CYCLES

- Warranty: The warranty of RC-Battery Pack is I year from the date of manufacturing.
- Guaranteed replacement in case of defects caused by the manufacturing process.
- Life cycles: 300 cycles, with a capacity above 80%
- The lifetime of the battery pack varies according to the storage, operational conditions, and environment.
